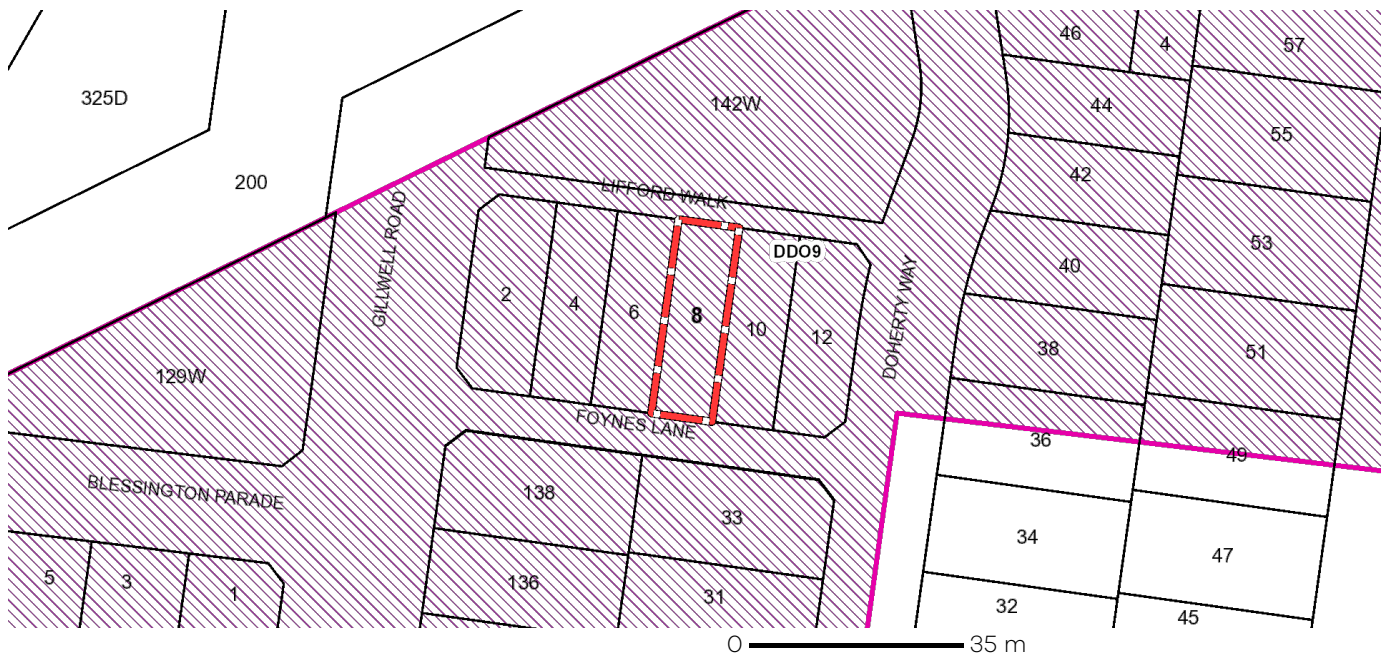

#### DESIGN AND DEVELOPMENT OVERLAY - SCHEDULE 9 (DDO9)

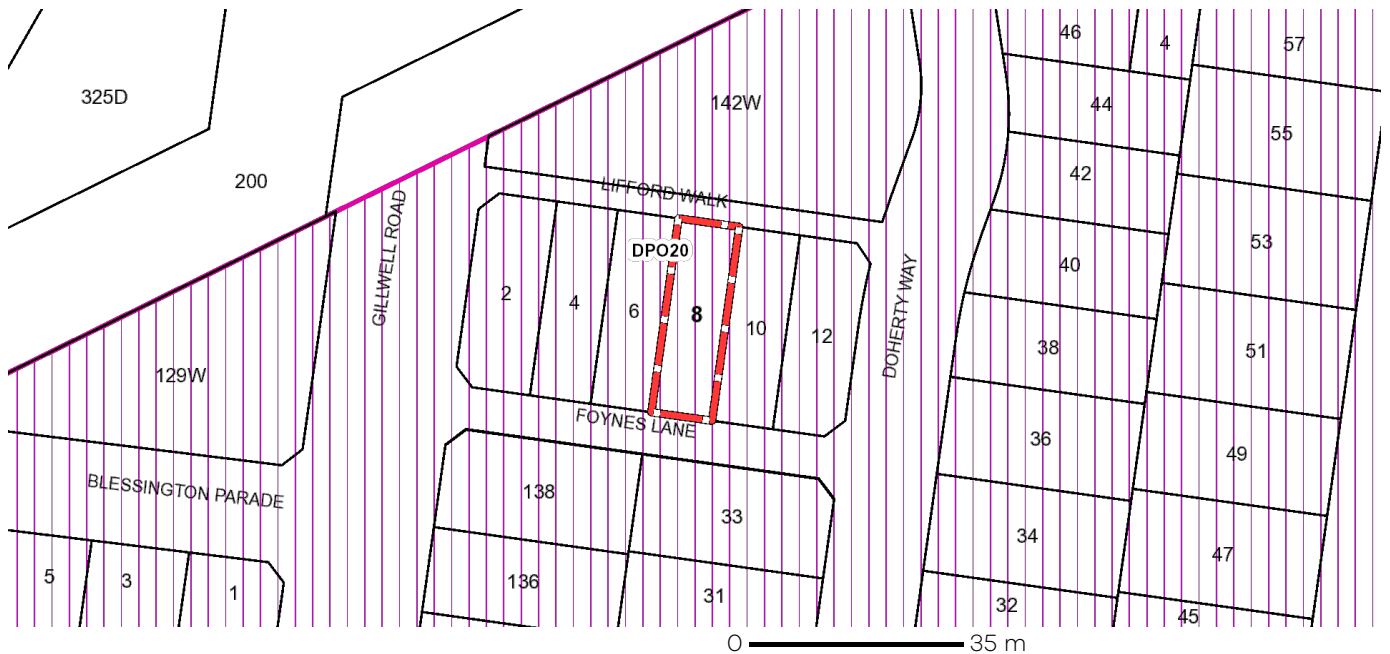


**DDO - Design and Development**
