Native Vegetation Removal

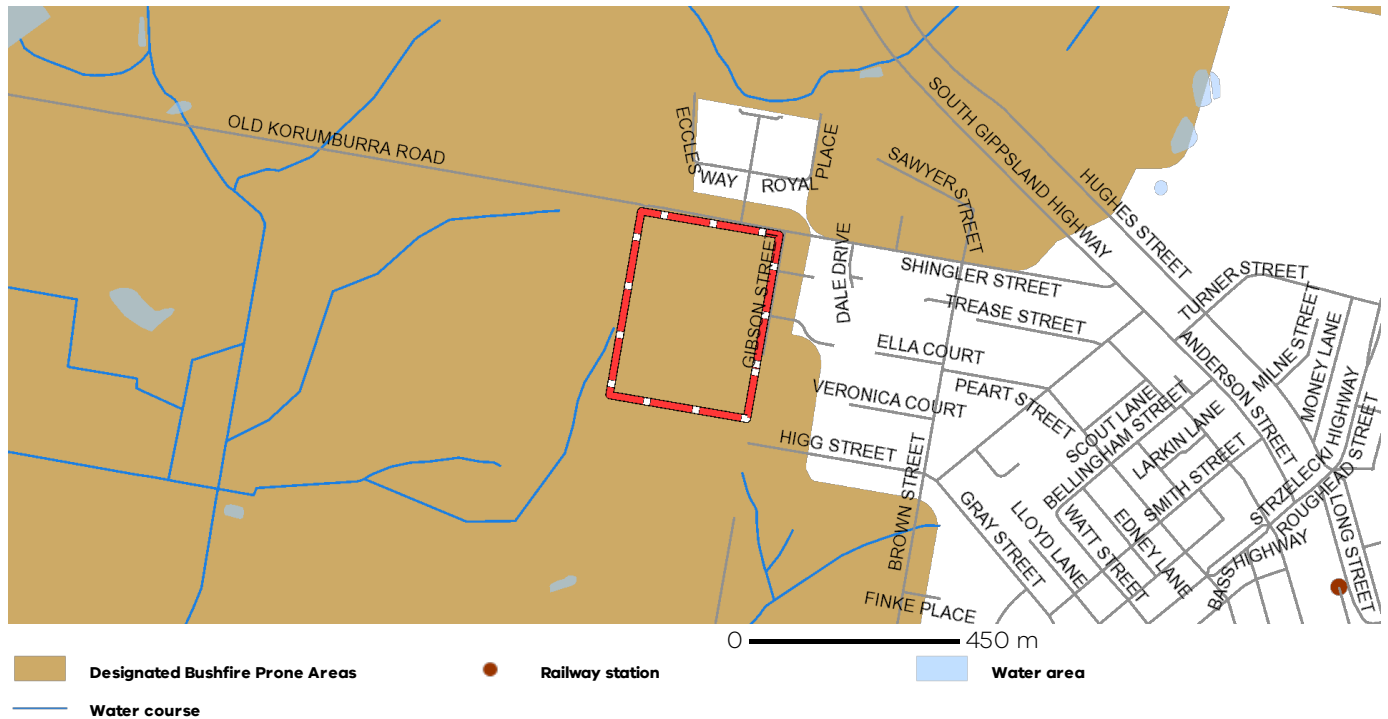
