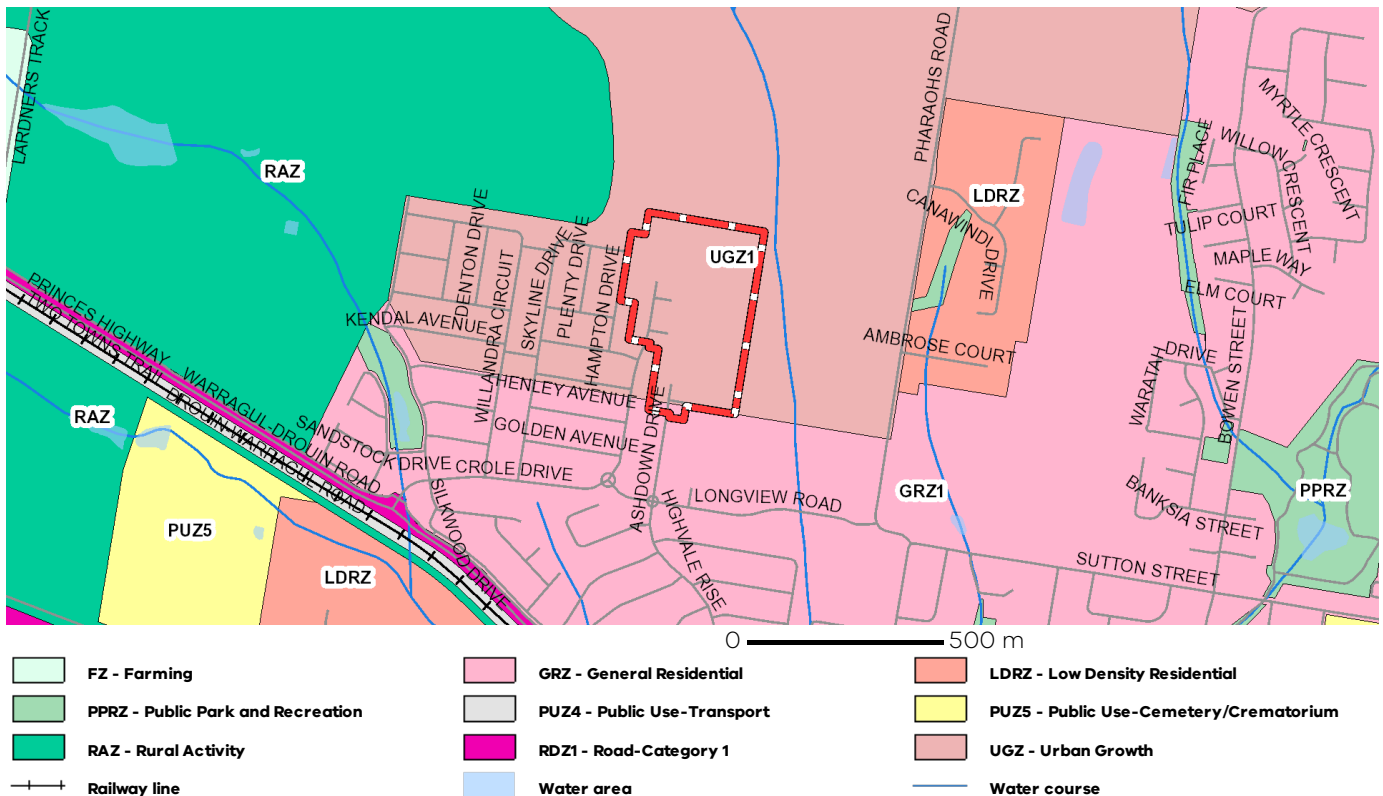

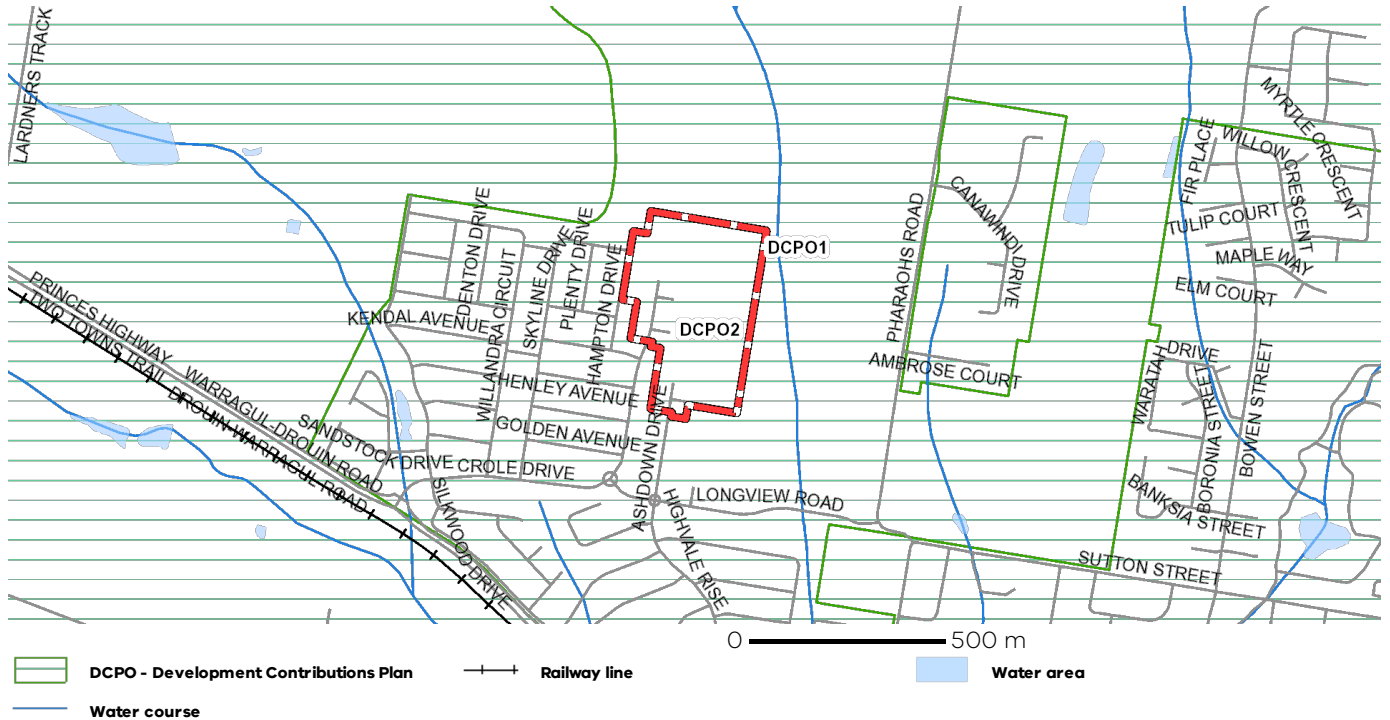

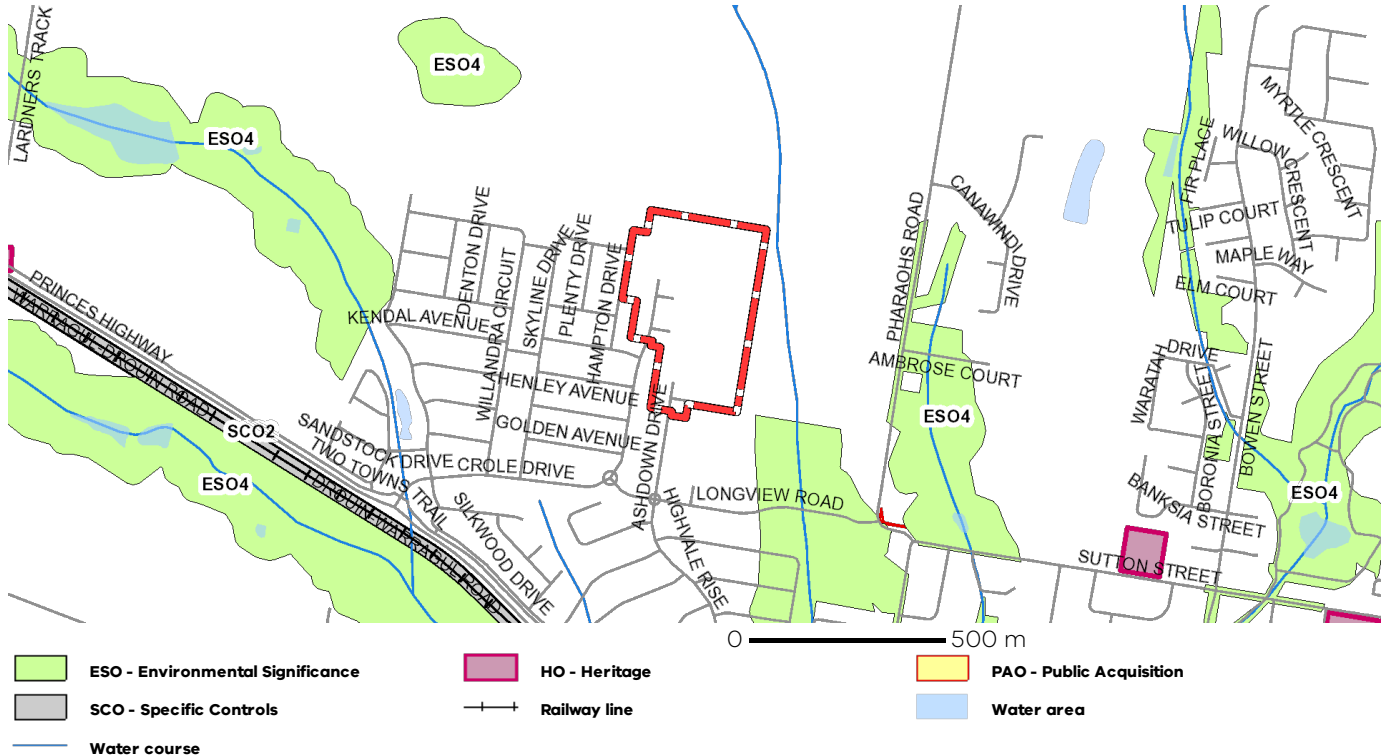

## Native Vegetation Removal

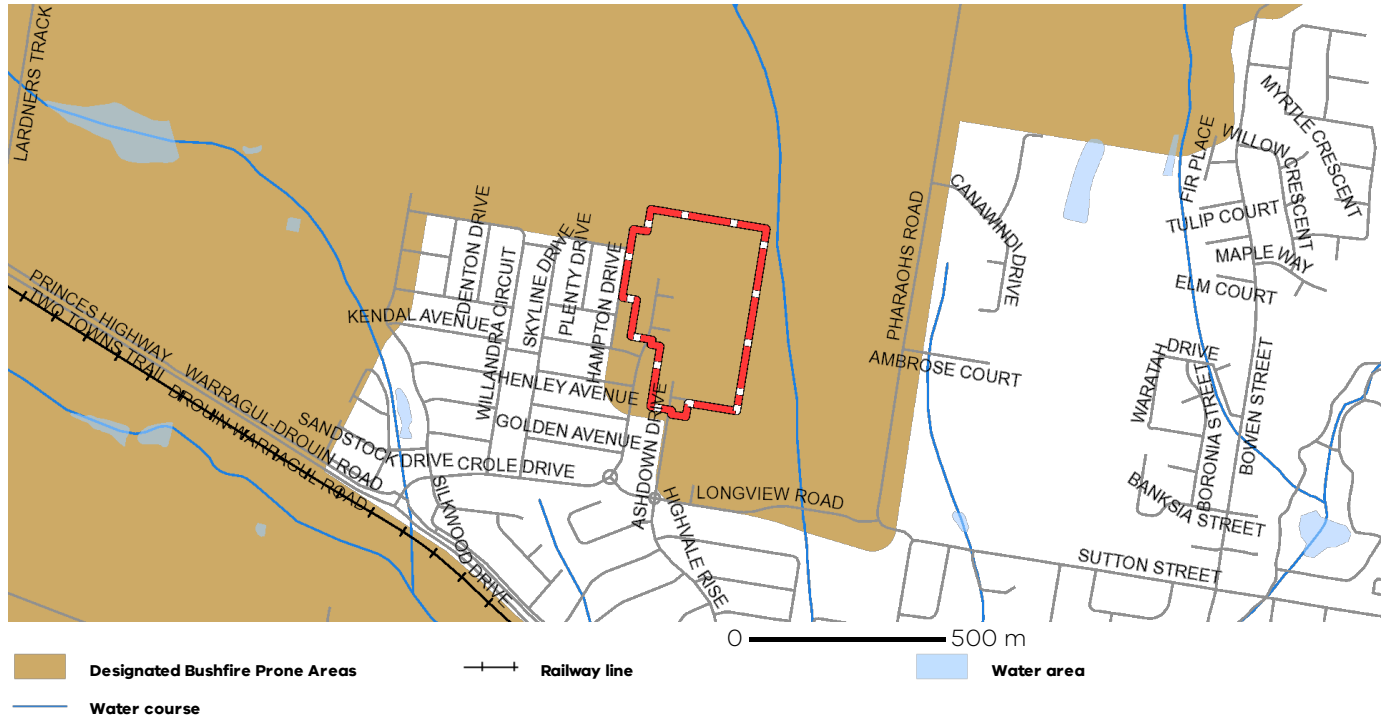
